AI-generated recommendations for coding adjustments and documentation enhancements to optimize claims.




API Integration to Implement Predictions

Key Outcomes from Claims with Denial Information



Claims Analyzed (with ERA)	767 denied claims
Denials Prevented	268 (37% of denials)
Financial Value Captured	\$47,757 potential savings
Avg. Value per Prevented Denial	\$178.20

Additional Financial Impact from Claims w/o Denial Information

Beyond the confirmed cases, ClearClaim also delivered significant value by identifying and preventing denials from claims lacking ERA confirmation.


